## City of Monterey Waiver and Hold Harmless

Permittee agrees to hold harmless, indemnify, and defend the City, its officers, agents, and employees, from any and all claims, suits, or actions made or brought against the City for death or injury to persons or destruction of property, loss, damage or liability which may be suffered or incurred by the City, its officers, agents, and employees caused by, arising out of, or in any way connected with exercise by permittee of the rights hereby permitted, except those arising out of the sole negligence or willful misconduct of the City.

Permittee shall provide a Certificate of Liability Insurance in the amount of \$1 million per occurrence, that indicates the insurance is primary, and provide an additional insured endorsement naming the following as insured:

City of Monterey, its officers, employees and agents City Hall, Police Department 351 Madison Street Monterey, CA 93940

The City shall have the privilege of inspecting the premises covered by this permit at any or all times.

The City may terminate this permit at any time, if permittee fails to perform any covenant herein contained at the time and in the manner herein provided, or if deemed necessary for the public welfare. The City agrees it will not unreasonably exercise this right of termination.

The parties hereto agree that the permittee, its officers, agents, and employees, in the performance of this permit, shall act in an independent capacity and not as officers, employees or agents of the City.

No alteration or variation of the terms of this permit shall be valid unless made in writing and signed by the parties hereto.

Permittee will not discriminate against any employee or applicant for employment because of race, color, religion, ancestry, sex, age, national origin or disability.

Permittee agrees to comply with the terms and conditions contained in the attached Exhibit(s), which terms and conditions are by this reference made a part thereof.

The permittee hereby agrees to comply with all the rules and regulations of the City of Monterey and the facility or institution subject to this permit.
